JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA AND THE RICHMOND COMMUNITY REDEVELOPMENT AGENCY BOARD APPROVING A MEMORANDUM OF UNDERSTANDING BETWEEN THE RICHMOND COMMUNITY REDEVELOPMENT AGENCY AND THE CITY ATTORNEY'S OFFICE OF THE CITY OF RICHMOND FOR THE PURPOSE OF PROVIDING LEGAL SERVICES FOR THE PROSECUTION OF BLIGHT ABATEMENT CASES FOR FISCAL YEAR 2007-2008 THROUGHOUT ALL REDEVELOPMENT PROJECT AREAS

WHEREAS certain properties throughout the Redevelopment Project Areas are severely blighted; and

WHEREAS the owners of these properties are not responsive to code enforcement efforts; and

WHEREAS more aggressive legal action is necessary to alleviate blighted conditions; and

WHEREAS The City Council and Richmond Community Redevelopment Agency have established abating blighted conditions in Richmond as a top priority.

NOW, THEREFORE BE IT RESOLVED that the Council of the City of Richmond and the Richmond Community Redevelopment Agency approve the Memorandum of Understanding between the Richmond Community Redevelopment Agency and the City Attorney's Office for the purpose of providing legal services for the prosecution of blight abatement cases in the amount of \$75,000 for Fiscal Year 2007-2008
