JOINT RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA AND THE RICHMOND COMMUNITY REDEVELOPMENT AGENCY BOARD APPROVING A MEMORANDUM OF UNDERSTANDING BY AND AMONG THE RICHMOND COMMUNITY REDEVELOPMENT AGENCY, THE CITY OF RICHMOND AND THE LIBRARY AND CULTURAL SERVICES DEPARTMENT FOR THE PURPOSE OF IMPLEMENTING A MURAL CLEAN-UP PROGRAM IN REDEVELOPMENT PROJECT AREAS.

WHEREAS, the Richmond Community Redevelopment Agency (“Agency”) is responsible for administering the Redevelopment Plans for Redevelopment Project Areas within the city in accordance with the California Redevelopment Law; and

WHEREAS, portions of Redevelopment Project Areas are characterized by blighting factors that include vandalism of public art installations, and such vandalism occurs to a degree exceeding what normal City of Richmond (“City”) services can adequately address; and

WHEREAS, the Redevelopment Plans authorize the Agency to cause the abatement of blighting conditions in Redevelopment Project Areas if normal City services are not adequate to address blighting conditions; and

WHEREAS, the Library and Cultural Services Department does not have the resources to address vandalism to public art installations that occurs in Redevelopment Project Areas; and

WHEREAS, vandalism in Redevelopment Project Areas is in excess of vandalism to public art installations in typical City neighborhoods; and

WHEREAS, funding for a Mural Clean-Up Program is provided in the Agency’s approved budget for fiscal years 2008-2009 through 2010-2011.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Richmond and the Richmond Community Redevelopment Agency Board that the Memorandum of Understanding by and among the Richmond Community Redevelopment Agency, the City of Richmond and the Library and Cultural Services Department to implement a Mural Clean-Up Program in Redevelopment Project Areas is hereby approved and the City Manager and Library and Cultural Services Director are authorized to execute the MOU on behalf of the City, and the Executive Director is authorized to execute the MOU on behalf of the Richmond Community Redevelopment Agency.
