

**RESOLUTION NO. 72-12**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, AUTHORIZING THE APPROPRIATION OF \$6,669 IN MATCH FUNDS FOR THE ASSISTANCE TO FIREFIGHTER'S GRANT AWARDED TO THE SAN RAMON VALLEY FIRE DEPARTMENT FOR THE PURCHASE OF BASE STATION RADIOS AND MOBILE RADIOS AND \$7,000 FOR INSTALLATION COSTS**

**WHEREAS**, the San Ramon Valley Fire Department was awarded a regional Assistance to Firefighter's Grant in the amount of \$2,383,353.00 for the purchase of base station radios and mobile radios as part of the Eastbay Regional Communication System (EBRCS); and

**WHEREAS**, the Federal grant share is 80 % or \$1,906,683.00 and the Local Government share is 20% or \$476,670.00; and

**WHEREAS**, the City of Richmond desires to accept two base station radios at a cost of \$1,906.00, and five mobile radios at a cost of \$4,763.00, from the San Ramon Valley Fire Department through the Assistance to Firefighter's Grant at a total cost of \$33,341.00; and

**WHEREAS**, the City of Richmond is required to cost share and pay upfront costs of 20% OR \$6,669.00, for two base station radios and five mobile radios, plus \$7,000.00 for installation costs at a total cost of \$13,669.00, to the San Ramon Valley Fire Department;

**WHEREAS**, the funding is available in the Fire Department's Fiscal Year 2011–2012 General Fund budget.

**NOW, THEREFORE BE IT RESOLVED**, by the Council of the City of Richmond that approval of the 20% local match or \$6,669.00 and installation cost of \$7,000.00, for a total cost of \$13,669.00 from the Fire Department's Fiscal Year 2011–2012 General Fund Budget be granted for the base station and mobile radios.
