RESOLUTION OF THE MEMBERS OF THE RICHMOND REDEVELOPMENT AGENCY, RICHMOND, CALIFORNIA APPROVING AND ADOPTING THE FIRST AMENDMENT TO THE REDEVELOPMENT AGENCY OPERATING BUDGET FOR FISCAL YEAR 2006 – 2007 AND CAPITAL IMPROVEMENT PLAN ("CIP") BUDGET FOR FISCAL YEARS ENDING 2007 - 2011.

WHEREAS, the Agency Board has determined that the planning and administrative expenditures are necessary for the production, improvement or preservation of low and moderate income housing as required by Health and Safety Code 3334.3(d); and

WHEREAS, said budget amendments are in accordance with the policy direction of the Members of the Redevelopment Agency.

NOW, THEREFORE, BE IT RESOLVED, that the Agency Board hereby approves and adopts the fiscal year 2006 – 2007 Operating and Capital budget amendments for the Redevelopment Agency, including Redevelopment, Economic Development and Housing & Community Development, as set forth in Exhibit "A" attached hereto.
