

**RESOLUTION NO. 83-19**

**A RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND,  
CALIFORNIA, FOR EMERGENCY REPAIRS FOR THE SINK HOLE PROJECT  
AT VALLEY VIEW RD FOR THE COST OF \$278,116  
(PROJECT COST OF \$238,726, PLUS VEOLIA 16.5% MARK-UP OF \$39,390)**

**WHEREAS**, on June 12, 2019, a significant sinkhole was detected by City of Richmond staff in the City of Richmond in the area near 4807 Valley View Rd; and

**WHEREAS**, the sink hole was due to a damaged sixty-inch storm drain pipe beneath the street surface; and

**WHEREAS**, since this repair would require immediate repairs, Veolia Water North America contacted Public Works Director, Yader Bermudez who, due to the critical nature of the situation, determined the City could forego the competitive bidding process; and

**WHEREAS**, Veolia Water then immediately contacted BayHawk, Inc. to report to the site and begin emergency repair work; and

**WHEREAS**, Veolia Water also contacted Traffic Management Inc., to design a traffic plan to safely route traffic around the sinkhole; and

**WHEREAS**, the City of Richmond contacted Nichols Consulting Engineers to provide the scope of work, hydraulic analysis, investigations of voids outside the pipe and evaluation of environmental concerns; and

**WHEREAS**, the Nichols Consulting Engineers proposal also includes preliminary engineering review, data research, and feedback regarding potential pipe lining technologies as well as dewatering; and

**WHEREAS**, the Valley View sink hole repair project, including design, debris removal and new construction, would be for an amount not to exceed \$278,116 (proposal cost of \$238,726 plus Veolia 16.5% mark-up of \$39,390); and

**WHEREAS**, the Water Resource Recovery Department issued a project Task Authorization to Veolia and Veolia Water West Operating Services, Inc. will manage the subcontracts with BayHawk, Traffic Management Inc. and Nichols Consulting Engineers; and

**WHEREAS**, these emergency repairs occurred subsequent to the adoption of the City's 2019-20 budget; and

**WHEREAS**, a portion of the proceeds of the Stormwater Developer Impact Fees in the amount of \$278,116 will be used for the purpose of funding the emergency repairs to Valley View Road (the "Project"); and

**WHEREAS**, in connection with the Project, the City desires to adjust its 2019-20 Stormwater Capital Program Budget to add \$278,116 to its expenditures.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Richmond, as follows:

Section 1. The foregoing recitals are true and correct and this City Council hereby so finds and determines.

Section 2. The Water Resource Recovery Department shall enter into a Contract with Veolia to manage of their behalf subcontracts with BayHawk, Traffic Management Inc. and Nichols Consulting Engineers, for the Emergency Repairs of the Valley View Sink Hole Project for an amount not to exceed \$278,116.

Section 3. The 2019-20 Stormwater Capital Program Budget is hereby adjusted to add \$278,116 to its expenditures.

Section 4. This resolution shall take effect immediately upon its passage.


